1. Purpose of MOU

4.1 Term of MOU: This MOU shall remain in effect for a period of 12 months with a six month review from the Effective Date, unless terminated earlier in accordance with its provisions.

4.2 Confidentiality: The parties commit to maintaining the confidentiality of any information shared during the cooperation and not disclosing it to third parties without prior written consent.

4.3 Governing Law: This MOU shall be governed by and construed in accordance with the laws of UK], without regard to its conflict of laws principles.

5. Review and Amendment

The parties may review and amend this MOU as needed to reflect changes in the cooperation's scope or objectives. Amendments shall be made in writing and signed by authorised representatives of both parties.

6. Entire Agreement

This MOU constitutes the entire understanding between RG Group and the Advisor concerning the subject matter herein and supersedes all prior or contemporaneous negotiations, understandings, and agreements, whether oral or written.

7. Execution

This Memorandum of Understanding shall be deemed executed and serves as an expression of the parties' preliminary understanding upon the signature of authorised representatives of both parties.
